This refers to your license amendment request dated August 27, 2021. Please find enclosed Amendment No. 6 changing the Radiation Safety Officer on the NRC license from David Hooper, P.E., to Scott Bruder, Certified Health and Safety Manager (CHSM).

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
