Dear Dr. Zhang:

Enclosed is Amendment No. 134 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-01284-02 in accordance with your July 21, 2021 request. Specifically, you requested to delete the licensed material listed in Item 6.H. from the license, delete the location of use at 1113 Parkview Plaza Dr., Suite 201, Fort Wayne, Indiana which was listed in License Condition 10.D. of the license, and add a new location of use located at 11115 Parkview Plaza Dr., Suite 201, Fort Wayne, Indiana.

The NRC staff has reviewed the information you provided regarding the decommissioning of the facility located at 1113 Parkview Plaza Dr., Suite 201, Fort Wayne, Indiana. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from this location and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material. Your facilities located at 1113 Parkview Plaza Dr., Suite 201, Fort Wayne, Indiana are suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with
