Enclosed is Amendment No. 109 to Beaumont Health System's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-01333-01 in accordance with your August 18, 2021 letter. As requested, the St. Clair Shores Family Medicine Center, 21400 E Eleven Mile Rd., St. Clair Shores location of use has been removed from your license. Also as requested, the PET/CT radioactive materials use authorization removal has been noted for your Outpatient Services Center, 44250 Dequindre, St. Clair Shores location of use. Please note that the PET/CT authorization for the Dequindre location of use will need to be re-added to your license, at such time when those licensed activities resume. Your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML21237A300.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at 630-829-9892 so that we may provide appropriate corrections and answers.

The NRC staff has reviewed your final status surveys for the St. Clair Shores Family Medicine Center location of use. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material at the 21400 E Eleven Mile Rd. location of use. Your facilities at 21400 E Eleven Mile Rd., St. Clair Shores, Michigan, are suitable for unrestricted use.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
