SUBJECT: RENEWAL OF RADIOACTIVE MATERIALS LICENSE FOR STATE OF MISSOURI, NRC LICENSE NO. 24-07974-03

Dear Mr. Kammerer:

Enclosed is Amendment No. 18 renewing your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-07974-03, in accordance with your April 26, 2021 renewal application. Please note that, License Condition No. 12 regarding the authorized users, No. 13 regarding the sealed source leak tests, No. 14 regarding the sealed source physical integrity, and No. 15 regarding the physical inventory were updated in accordance with our licensing policy. In addition, we deleted License Condition No. 16 regarding the transportation requirement and No. 17 regarding the increased control requirement because these requirements are already in the regulations in 10 CFR parts 71 and 37, respectively. Based on the addition of depleted uranium as shielding in the high range calibration unit, we added secondary program code 11210 - Source Material Shielding to your license per 10 CFR 171. For your references, the description of the program codes is posted on the NRC website at <https://www.nrc.gov/materials/miau/mat-toolkits.html> and 10 CFR 171 at <https://www.nrc.gov/reading-rm/doc-collections/cfr/part171/part171-0016.html>.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
