PART I.D -- COMMENTS

Upon receipt of your request on September 7, 2021, the Office of Nuclear Material Safety and Safeguards (NMSS) and our Region IV (RIV) office were tasked to conduct a search for responsive records.

RIV staff has informed us that per 10 CFR 72.13, the requirement 72.192 does not apply to SONGS. SONGS ISFSI is licensed as a "General Licensee" not a "Specific Licensee." Therefore, following HI-STORM FW/UMAX FSAR Section 13.2.1, training must be completed under the General licensee's Part 50 systems approach to training program. The training violation was changed from 72.192 to 72.190. This information is provided in the NRC Special Inspection Report "Errata" located on our public webpage, <https://www.nrc.gov/reactors/operating/ops-experience/songs-spec-insp-activities-cask-loading-misalignment.html> (link was provided to you in a previous FOIA request, NRC-2019-000243). In addition, the NRC Special Inspection Report also provides NRC's documentation as it pertains to a smaller practice cannister than the actual cannister used.

There were no additional records located as responsive to your request.
