This refers to your license amendment request dated August 19, 2021. Please find enclosed Amendment No. 12 authorizing the requested change in Radiation Safety Officer (RSO). Please be aware that your license conditions were updated to align with NUREG-1556 Volume 20, Revision 1, "Consolidated Guidance About Materials Licenses: Guidance About Administrative Licensing Procedures".

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
