What is Environmental Justice?

Environmental justice refers to the federal policy established in 1994 by Executive Order (EO) 12898, which directed federal agencies to identify and address disproportionately high and adverse human health or environmental effects of its programs, policies, and activities on minority and low-income populations.



What is the NRC's current policy on Environmental Justice?

In 2004, the Commission issued its “**Policy Statement on the Treatment of Environmental Justice Matters in NRC Regulatory and Licensing Actions**” (69 FR 52040)

- Consider environmental justice in reviews under the National Environmental Policy Act (NEPA).
- Focus is on disproportionately high and adverse impacts on environmental justice communities.

- A. Evaluate recent Executive Orders and assess whether environmental justice is appropriately considered and addressed given the agency's mission.
- B. Consider the practices of other Federal and State agencies and Tribal governments, and evaluate whether the NRC should incorporate environmental justice beyond implementation through NEPA.
- C. Review the adequacy of the 2004 Commission Policy Statement.
- D. Consider whether establishing formal mechanisms to gather external stakeholder input would benefit any future environmental justice efforts

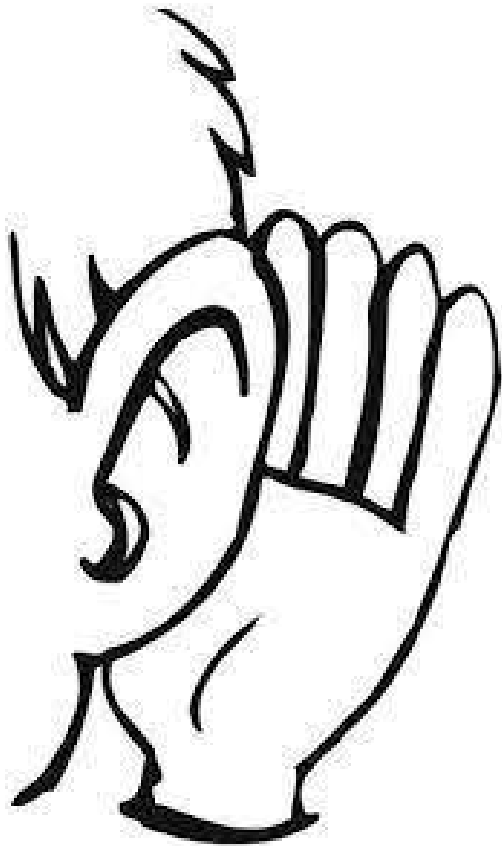
Gathering and considering perspectives

Developed a flexible outreach strategy that allows us to learn and adapt.

- **Public comment** - *Federal Register* notices and related meetings
- **Targeted outreach** to community leaders and groups active in environmental justice, governments --Tribal, local, state and federal – industry, licensees, and labor unions.
- **Internal outreach** to NRC staff

What we've heard

Barriers to meaningful engagement

- NRC's reliance on IT for notices and public meetings
- Lack of broadband internet access
- Lack of consistent communication from NRC
- Communication from NRC is not always easily understandable

What we've heard

- The NRC should not limit consideration of EOs in its EJ Review.
- NRC should consider a number of executive orders that have been issued since EO 12898, such as EOs 13985, 13990 and 14008

What we've heard

- **NRC's approach of the Policy Statement reflects outdated thinking on justice concepts and should be revised, e.g., Census data tools might not truly reflect the social, economic, and racial makeup of communities**
- **The policy statement does not guarantee that the NRC will uphold the principles of environmental justice and ensure that all U.S. populations are treated fairly and included in decision-making processes that relate to the environment**
- **The 2004 Policy Statement does not address tribal engagement, and this should be done early in the licensing process**
- **NRC should include Racial Discrimination in siting and Environmental Racism in evaluating licensing actions**

What ways could the NRC enhance identification of environmental justice communities?

How could the NRC enhance opportunities for members of environmental justice communities to participate in licensing and regulatory activities?

What we've heard

- NRC should cultivate relationships with State and local governmental and non-governmental organizations and other community leaders (e.g., church leaders and networks)
- NRC should tailor outreach efforts to the specific community considering the differences and challenges that might exist
- NRC should convey technical information in a manner that is clearly understood by all members of the community
- NRC should provide opportunities for early notification and input into both safety and environmental aspects of licensing

What actions could the NRC take to enhance consideration of environmental justice at the NRC, considering the agency's mission and statutory authority?

What we've heard

- NRC should create an organization or advisory committee within the NRC with staff solely dedicated to performing outreach and facilitating meaningful engagement with EJ Communities
- NRC should respect Sovereign Tribal Nations by offering consultation early in the decision-making process
