Dear Mr. Zakrzewski:

Enclosed is Amendment No. 8 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 34-24957-02 in accordance with your September 21, 2021 request.

In accordance with your request, this amendment includes the following changes to your license:

- authorization for the Troxler Electronic Laboratories Model 3411-B, 3430, 3440, 3450 and 4640 portable gauging devices;
- adjusted the authorization for the total activity of the CPN International Division of InstroTek, Inc., Model MC Series PORTAPROBE portable gauging devices;
- addition of the permanent storage sites in Dover and Wilmington, Delaware; and
- updated Radiation Protection Program commitments.

Additional permanent storage sites identified in your request are within Agreement States. Therefore, you should contact the applicable Agreement State Program to request licensed authorization to use these additional permanent storage sites within their jurisdiction. Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
