Our office has reviewed the July 15, 2021 request for NRC to amend IOM Health System, LP d/b/a Lutheran Hospital of Indiana's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-01535-01 to add a [Title 10 of the Code of Federal Regulations \(CFR\) Section 35.1000](#) yttrium-90 as TheraSphere authorization for your existing 10 CFR 35.1000 yttrium-90 as SIR-Spheres Authorized User (AU) Saad M. Ibrahim, M.D. As confirmed via your October 18, 2021 email, because Dr. Ibrahim has not yet completed his TheraSphere training, your request has been withdrawn and this action has been administratively closed. This administrative closure is without prejudice to resubmission.
