SUBJECT: APPROVAL OF AMERICAN CENTRIFUGE OPERATING REQUEST TO USE DIGITALLY BASED ITEMS RELIED ON FOR SAFETY IN THE HIGH ASSAY LOW-ENRICHED URANIUM DEMONSTRATION PROGRAM AT THE AMERICAN CENTRIFUGE PLANT (EPID L-2020-LLA-0125)

Dear Kelly Fitch:

By letter dated June 30, 2021 (Agencywide Document Access and Management System [ADAMS] Accession No. ML21196A038), American Centrifuge Operating (ACO), a wholly owned subsidiary of Centrus Energy Corp. (Centrus), requested that the U.S. Nuclear Regulatory Commission (NRC) modify its Materials License SNM-2011 and Supporting Documents for the American Centrifuge Plant (ACP) in Piketon, Ohio. The Licensee's letter requested the NRC to review and approve proposed changes to LA-3605-0001, "License Application for the American Centrifuge Plant", LA-3605-0003, "Integrated Safety Analysis Summary for the American Centrifuge Plant," and License Condition 19 (LC 19) of NRC's Materials License SNM-2011. Specifically, in accordance with LC 19, ACO has requested the NRC to review and approve use of digitally based items relied on for safety in the High Assay Low-Enriched Uranium demonstration program at the ACP.

The NRC staff has completed its review of these documents and have found them to be acceptable. The details associated with the review are documented in the enclosed non-public safety evaluation report (SER). In response to the application, the NRC has revised LC 19 to the enclosed license SNM-2011 related to implementation changes for items relied on for safety (IROFS).

Enclosures 1 and 3 transmitted herewith contain security-related information. When separated from the sensitive conditions in the enclosures, this document and Enclosure 3 are decontrolled.
