SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-36845/2021-001 AND NOTICE OF VIOLATION

Dear Mr. Turpin:

On September 17, 2021, the U.S. Nuclear Regulatory Commission (NRC) cited JFC Engineering and Surveyors, for four violations involving failures to: (1) perform leak test on the portable gauges at the frequency required by the NRC; (2) maintain a use logbook for gauge accountability; (3) conduct semi-annual inventories on the gauges, and (4) failure to conduct periodic (at least annually) reviews of the radiation safety program. NRC Inspection Report 030-36845/2021-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession No. [ML21259A262](#)). By letter dated September 29, 2021, you provided your reply to the Notice (ADAMS Accession No. [ML21292A229](#)) with additional clarification via email on October 19, 2021 (ADAMS Accession No. [ML21292A211](#)).

After reviewing the information provided in your reply to the Notice, we have concluded that your corrective actions appear to adequately address the regulatory non-compliances described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
