- a. Do you intend Doug Boyd to be listed as the RSO on the Southeastern Land, LLC license?
- b. Do you intend to have the application dated July 16, 2012, currently listed as the commitments for the Coal-Mac license, to also be listed on the Southeastern license? If so, do you wish to amend the Southeastern license to remove their commitments dated /January 11, 2012 (ML12025A064) [note: this is the renewal application from CONSOL of Kentucky, the licensee at that time.] and July 29, 2016 (NL16235A339) [note: this commitments made by Southeastern Land during a 2016 change of control.]
- c. Based on item 1, I believe you intend the name on the license to be changed to Coal-Mac LLC. Confirm if that is correct.
