Dear Mr. Levine:

This letter refers to your license renewal application dated September 1, 2021, Agencywide Documents Access and Management System (ADAMS) Accession no. ML21252A200, received on September 9, 2021. In reviewing your application, we have determined additional information is required to complete our review. In order to continue our review, please address the issues listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) Section 32.14, "Manufacture, distribution and transfer of exempt quantities of byproduct material: Requirements for license," and 10 CFR 40.52, "Certain items containing source material; requirements for license to apply or initially transfer."

1. Please provide copies of your current possession licenses issued by the State of Pennsylvania and the State of Ohio.
2. The current name of your NRC license is "Eye Lighting International of North America," which is different from your application Item No. 2, "Eye Lighting International." Please explain if this is name change only, or ownership change.
3. Provide details of construction and design of each product, and the method of containment or binding of the byproduct material in the product.
4. Please provide a list of the products with model numbers that shows which model containing Krypton-85 and/or Thorium-232.
5. Provide the method of labeling or marking each unit, and its container with the identification of the manufacturer or initial transferor of the product and the byproduct material in the product.
6. For lamps containing thorium, provide quality control procedures to be followed in the fabrication of production lots of the product and the quality control standards the product will be required to meet.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the U.S. Nuclear Regulatory Commission (NRC) may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's ADAMS.
