This is in reference to your letter dated July 20, 2021, requesting to amend NRC License No. 29-13141-06. In order to continue our review, we need the following additional information:

The NRC views a letter signed by a management representative as indication that management has reviewed the application and concurs in the statements and representations contained therein. As such, please provide the following:

- a. Please confirm that you, Mr. Colin O'Connor, are authorized to make legally binding commitments on behalf of the licensee's organization; OR,
- b. If you are not authorized to make legally binding commitments on behalf of the licensee's organization, please provide either of the following
 - i. Provide a signed letter from an individual with such authorization confirming that he/she endorses the requests and statements submitted by you, Mr. Colin O'Connor, on behalf of your organization in the amendment request dated July 20, 2021; OR
 - ii. Provide a signed letter from an individual with such authorizations confirming that he/she does not endorse the requests and statements submitted by you, Mr. Colin O'Connor, on behalf of your organization in the amendment request dated July 20, 2021 and request to withdraw the requests and statements.
- c. Awareness Only, No Response Required - Please ensure that all future requests are signed by an individual authorized to make legally binding commitments on behalf of the proposed licensee's organization, including the response to this request for additional information

In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this letter.

While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary.
