As required by SRPAR 0400-20-10-.13, 0400-20-10-.25 and Condition 16 of our Tennessee Radioactive Material License R-01082-B23, Berthold Technologies USA is filing our quarterly report for the 3<sup>rd</sup> quarter of 2021 for radioactive material general licensees falling under the direction of the Nuclear Regulatory Commission.
