Dear Ms. Flaherty:

Enclosed is Amendment No. 95 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 12-16941-01 in accordance with the requests dated July 28, 2021, July 29, 2021 and August 5, 2021, all signed by John T. Thornton, PSI Safety Director/CRSO, and your letters dated September 8, 2021 and October 29, 2021.

In accordance with the above requests, this amendment includes the following changes to your license:

- change in the appointed Radiation Safety Officer;
- addition of the permanent storage site in Detroit, MI;
- updated facility diagram for your permanent storage site in Maryland Heights, MO;
- removal of the permanent storage site in St. Louis, MO; and
- adjusted the authorization for the number and total activity of InstroTek, Inc., Model 3500 portable gauging devices.

The letters dated July 29, 2021 and September 8, 2021 identified that all radioactive materials have been removed from your former permanent storage in St. Louis, Missouri. Further, your request provided a closeout survey report and leak test reports for your portable gauging devices.

I have reviewed this information and have concluded that all licensed radioactive materials have been removed from your facility and there is no evidence of residual radioactive contamination attributable to licensed activities. Therefore, the former facility is suitable for release to unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 Code of Federal Regulations (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC.
