Glenn,

The letter dated July 26, 2021 states that there is an organizational name change of the parent company, from Cardinal Health 100 Inc. to Cardinal health 100, LLC. An organization chart was provided.

- The change from an corporation (Inc.) to a limited liability company (LLC) is a change in the business entity and the way it is owned, managed, and taxed. It is not simply a name change. Provide information related to this change which describes any changes in the organization such as transfer of stocks or other assets, change in the members of (or use of) a Board of Directors, or other such changes that could be a change in the control over Cardinal Health 414, LLC.
- The organization chart provided with the July 26 letter does not show an entity named Cardinal Health 100, LLC. There appears to be a parent company “Cardinal Health Pharmaceutical Segment” which appears to be owned by another company “Cardinal Health”.
  - State which of the entities listed on the organization chart provided with the July 26 letter is Cardinal Health 100, LLC; or provide another organization chart.
  - Provide an organization chart that shows the structure with Cardinal Health 100 Inc. prior to the change to Cardinal Health 100, LLC, as required by NUREG-1556 volume 15. The current renewal of the license does not include an organization chart which shows the previous organization. The most recent organization chart I was able to find was in the 2011 application, and it is very different from the organization chart provided.
