Westinghouse Electric Company LLC (Westinghouse) is pleased to provide NRC both a public and non-public version of Revision 5 of the Final Safety Analysis Report (FSAR) for the FuelSolutions™ Storage System (Reference 1). Page changes for Revision 5 were previously provided to NRC via Reference 2. The purpose of this submittal is to provide Revision 5 of the FSAR in its entirety.
