I need some additional info for Mr. Schultz. In your letter dated 08/04/21, you provided info re: Mr. Schultz's ABR certification. However, I need a copy of the certification itself, because I need to see that it meets the requirements date-wise and has "AMP Eligible" above the ABR seal.
