By letter dated November 1, 2021 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML21305B797), Southern Nuclear Operating Company (SNC) submitted an exemption request for Vogtle Electric Generating Plant, Units 3 and 4. The requested exemption is from the specific requirements in Title 10 of the Code of Federal Regulations (10 CFR) 73.55(a)(4) and 73.56(a)(3).

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission staff's acceptance review of this request. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the staff to complete its detailed technical reviews. The acceptance review is also intended to identify whether the submittal has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

The staff has reviewed your application and concluded that it does provide technical information in sufficient detail to enable the staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed exemption. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the staff's ability to complete the detailed technical review are identified despite completion of an adequate acceptance review. SNC will be advised of any further information needed to support the staff's detailed technical review by separate correspondence.

SNC has requested staff approval of this exemption by December 1, 2021. The staff will try to complete its review by this date unless we agree to a different date at a later time due to circumstances beyond our control. The staff estimates that it may take 175 hours to complete this licensing action.
