This refers to your license amendment request dated October 1, 2021. Please find enclosed Amendment No. 2 authorizing a new location of use at Torre San Cristóbal, Office #109, Coto Laurel, Puerto Rico. Please note this location was formerly authorized under Dr. Gamalier Bermudez/Modern Radiology PSC (NRC License No. 52-31059-01). This location, equipment, sealed sources, and applicable license tie-down conditions authorized under NRC license number 52-31059-01 have been added to this license. The termination of the Dr. Gamalier Bermudez/Modern Radiology PSC license is being processed concurrently under mail control number 628898.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
