Vistra Operations Company LLC (Vistra OpCo) hereby submits as specified in 10 CFR 50.4(b)(4) a report of changes contained in Revision 13 of the Comanche Peak Nuclear Power Plant (CPNPP) Units 1 and 2 Physical Security Plan (PSP). The changes were assessed per 10 CFR 50.54(p) and were determined not to reduce the safeguards effectiveness of the PSP. The Plan revision was made effective on September 22, 2021.
