Summary:

The NRC is considering issuance of an exemption in response to the December 23, 2020, request from HDI related to Palisades. The exemption would permit HDI to use funds from the Palisades nuclear decommissioning trust for spent fuel management and site restoration activities. The exemption would also allow such withdrawals without prior notification to the NRC.

The NRC staff plans to issue the final EA and final FONSI associated with the proposed exemption in November 2021.
