From Casey's email

1. Could you please confirm if you would like authorization to work/store material at temporary job sites? WLC would like authorization to work/store material at temporary job sites after first verifying the public safety of a temporary storage location via a location map and public dose calculations for our records.
2. Could you please confirm which of these statements that you are committing to? There appeared to be a checkmark/slash on both options in your submittal.
  - a. We will maintain, for inspection by the NRC, documentation demonstrating that unmonitored individuals are not likely to receive a radiation dose in excess of the limits in 10 CFR 20.1502(a). WLC does this as part of annual review. However, WLC will commit to 2b., below.

WLC will commit to the Statement below for monitoring occupational individuals.
  - b. We will provide and require the use of individual monitoring devices (dosimetry). All personnel dosimeters that require processing to determine the radiation dose will be processed and evaluated by a NVLAP-approved processor.
3. Could you please confirm which of these statements that you are committing to? There appeared to be a checkmark/slash on both options in your submittal.
  - a. We will implement and maintain the operating, emergency, and security procedures in Appendix G to NUREG-1556, Vol. 1, Rev. 2, "Consolidated Guidance About Materials Licenses: Program- Specific Guidance About Portable Gauge Licenses." I am reviewing your application for the renewal of NRC License No. 49-27067-01 and I have a few questions. Could you please provide the answers to the following in a signed letter? You can attach that letter to an email if it that is easiest.

Also, please note that your submittal talked about a change in the ownership structure of the company. Our Regional Counsel has determined that the restructure does not qualify as a change of control. I will note that in the final renewal paperwork as well, but I wanted to let you know ahead
