SUBJECT: SUMMARY OF THE OCTOBER 27, 2021, PUBLIC MEETING
WITH THE UNIVERSITY OF ILLINOIS AT URBANA-
CHAMPAIGN TO DISCUSS THE DRAFT REGULATORY
ENGAGEMENT PLAN (EPID L-2021-NFN-0002)

On October 27, 2021 (Agencywide Documents Access and Management System (ADAMS Accession No. ML21299A364), the U.S. Nuclear Regulatory Commission (NRC) staff held a public meeting with representatives from the University of Illinois at Urbana-Champaign (UIUC). The purpose of this meeting was to discuss UIUC's regulatory draft engagement plan (ADAMS Accession No. ML21288A168). UIUC plans to submit an application for a construction permit, followed by an application for an operating license for a test reactor facility for the Micro-Modular Reactor high temperature gas-cooled reactor design developed by the Ultra Safe Nuclear Corporation. The meeting commenced with a presentation by the NRC staff regarding NRC's role pertaining to test reactors construction permit applications (ADAMS Accession No. ML21299A320). This was followed by a presentation from UIUC and its contractors pertaining to its regulatory engagement plan. The presentation covered the project overview, preliminary siting, environmental review, technology overview, and regulatory strategy (ADAMS Accession No. ML21301A225). The enclosure to this memorandum lists the meeting attendees.

After the business portion of the meeting, a member of the public expressed concerns with siting a test reactor at the UIUC campus. The NRC staff explained that its regulations and supporting review guidance cover siting and radiation protection for the NRC staff to use when reviewing an application for a new facility. The NRC staff's review guidance specifically addresses siting of these facilities in densely populated areas. The NRC staff also noted that there are many research reactors located on college campuses across the country, including in urban areas.

The same member of the public also asked how the proposed facility could be considered a research and development facility and not a commercial reactor when UIUC stated that it intends to use the facility to provide some electricity and/or heat energy for the UIUC campus. The NRC staff explained that the Atomic Energy Act of 1954, as amended (AEA), includes provisions that could allow a research and development facility to produce electricity provided that it meets certain criteria and limitations. The NRC staff stated that UIUC's application for an NRC permit or license will need to include enough detail about the intended research activities and energy production capabilities for the NRC staff to determine whether the facility can be licensed as a research and development facility, or whether it would be classified as a commercial facility. The AEA provides a list of research and development activities such as researching the production of atomic energy, nuclear processes, and using radioactive material for medical, biological, or health purposes. As part of its review, the NRC staff would ensure that the UIUC's intended use of the proposed facility is consistent with the research and development activities described in the AEA and the limitations on electricity production. No other public comments or questions were provided during the public comments portion of the meeting.
