1. **NRC letter to NNEPA** –response to D. Yazzie’s request during our meeting on 10/29; letter is being drafted/goal for NRC to issue by the end of the month
2. **Draft Programmatic Agreement (PA) for comment** – Draft PA will be published for comment on November 30 for 45-days, NNEPA received an advanced copy via email on 11/15.
