### To whom it may concern:

On November 12, 2021, Materials Testing Consultants, Inc. ("MTC") (EIN: 38-1866284) submitted an application (Reference 1), followed by a supplemental application on November 17, 2021 (Reference 2), requesting consent from the U.S. Nuclear Regulatory Commission ("NRC") for a proposed indirect transfer of control of its NRC license. This letter supersedes the November 12, 2021 and November 17, 2021 letters and removes the previous request for confidential treatment.

Pursuant to Section 184 of the Atomic Energy Act of 1954, as amended, and 10 C.F.R. § 30.34(b), MTC, on behalf of itself and MTC Corporate Holdings, Inc. ("MTC Corporate Holdings"), a Delaware corporation, (together with MTC, "Applicants"), hereby requests consent from the NRC for the proposed indirect transfer of control of the following NRC license:

• Materials Testing Consultants, Inc., License No. 21-15281-02 (Docket No. 030-13918) (the "License").

For pressing business reasons, including the pending consummation of the Transaction (as defined below), the Applicants request expedited review and consent to the Transaction by December 31, 2021 and prompt posting of this application to the NRC website for the 30-day comment period.

The indirect transfer of control would occur upon the closing (the "Closing") of a planned business succession transaction (the "Transaction") under which MTC Corporate Holdings would acquire a majority of the outstanding equity of MTC from its current owners, as described more fully in the enclosed Application. MTC Corporate Holdings, in turn, will be ultimately controlled by TMCH Platform Three, LLC ("TMCH3"), a Delaware limited liability company. Post-Closing, MTC would still hold the License, with no changes to the employees, equipment, facilities, personnel and procedures who are responsible for licensed activities. The only change related to licensed activities is that the License held by MTC would be majority-owned by MTC Corporate Holdings and ultimately by TMCH3 (although certain of the current MTC owners would retain a minority ownership interest on Exhibit B). Exhibit A provides the license transfer appplication. Exhibit B presents a simplified pre- and post-Closing organizational chart. TMCH3 confirms that it agrees to the indirect change of control and has been made aware of any NRC inspection findings. Under the terms of the transaction, MTC will remain responsible for any possible resulting enforcement actions. MTC, as the holder of the license, will continue to abide by all commitments contained in the license. In addition, upon the closing of the transaction, TMCH3 understands that MTC will abide by all commitments made prior to the indirect change of control.

Applicants expect the Transaction to close upon receipt of the NRC approval. MTC therefore respectfully requests the NRC's expedited review and written approval of this application by December 31, 2021 to support the Closing schedule. MTC further requests that the NRC promptly post this application to its website for the 30-day comment period.

### Exhibit A

## **License Transfer Application**

1. Describe any planned changes in the organization, including but not limited to, transfer of stocks or assets and mergers, change in members on Board of Directors, etc. Provide the new licensee name, mailing address, and contact information, including phone numbers. Clearly identify when the amendment request is due to a name change only.

MTC is currently owned by four trusts as shown on <u>Exhibit B</u>, each with equal ownership interests in MTC. On August 15, 2021, MTC and MTC Corporate Holdings entered into an agreement, subject to certain conditions, that provides for the acquisition by MTC Corporate Holdings of all of the issued and outstanding stock of MTC, giving a controlling interest in MTC to MTC Corporate Holdings. At the closing, TMCH Platform Three, LLC ("TMCH3") would acquire indirect control over MTC through its 83.33% ownership of Testing & Engineering Consultants, LLC, the sole owner of MTC Corporate Holdings.

The Transaction will not impact licensed activities under the License. Following the Closing, MTC will still hold the license, with no changes to the employees, equipment, facilities, personnel and procedures responsible for licensed activities. MTC will remain in business at the same addresses and with the same Radiation Safety Officer listed in License. For certain activities other than those relating to licensed activities, TMCH3 will have control of MTC Corporate Holdings. Day-to-day actions of TMCH3 will simply require approval by either Michael O'Neill or Erik Latterell, each of whom is a U.S. citizen as well as a founder and officer of TMCH3, except that authority to control licensed activities will remain with the Radiation Safety Officer. Michael O'Neill and Erik Latterell do not have involvement with day-to-day MTC operations related to license activities. The personnel actually involved in the day-to-day operations are not substantially changed. Major decisions, such as acquisitions, recapitalization, or a sale of the company require supermajority approval of the investors in TMCH3. The remainder of the owners in TMCH3 would be passive investors who have no control over any of the activities of MTC, MTC Corporate Holdings, or TMCH3. Certain of the current owners of MTC plan to retain a minority ownership interest in MTC Corporate Holdings.

2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel and any changes in the training program.

There are no planned changes in personnel or the duties that relate to the licensed programs.

3. Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program.

There are no such changes planned in connection with the Transaction.

4. Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records.

The status of MTC's licensed equipment and radiation safety programs will not change in connection with the Transaction. There is no known contamination. All calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records are current.

5. If current decommissioning funding plans (DFP) will be changed as a result of the transfer, the revised DFP should be submitted. If other financial assurance documents will be changed as a result of the transfer, confirm that all financial assurance instruments associated with the license will be held in the transferee's name before the license is transferred, and as required by 10 CFR 30.35(f), the licensee must, within 30 days, submit financial instruments reflecting such changes.

DFP or financial assurance instruments are not required under the License.

6. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.

MTC Corporate Holdings and TMCH3 have confirmed all such records will remain with MTC, are current, and will be current at the time of the change of control.

7. Confirm that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions.

MTC, MTC Corporate Holdings, and TMCH3 have agreed to the change in control over the License. There are no open inspection items pertaining to the License.


8. Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.

MTC, MTC Corporate Holdings, and TMCH3 will continue to abide by all constraints, conditions, requirements, representations, and commitments of MTC.

9. The transferee, in the case of fuel cycle facilities, shall provide documentation showing that it is financially qualified to conduct normal operations. The information can be in the form of income statements and balance sheet forecasts.


