LICENSEE:

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Nuclear Regulatory Commission (NRC) rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are as follows:

- 1. Based on the inspection findings, no violations were identified.
- 2. Previous violation(s) closed. (IR2016-001)
- 3. The violation(s), specifically described to you by the inspector as non-cited violations, are not being cited because they were self-identified, non-repetitive, and corrective action was or is being taken, and the remaining criteria in the NRC Enforcement Policy, to exercise discretion, were satisfied.

- 4. During this inspection, certain of your activities, as described below and/or attached, were in violation of NRC requirements and are being cited in accordance with the NRC Enforcement Policy. License Condition 18.B of NRC License 47-31404-01, Amendment No. 2, dated May 5, 2020, requires, in part, that the licensee shall conduct its program in accordance with the statements, representations, and procedures contained in the documents, including any enclosures, in the letter dated April 15, 2020.

In the letter dated April 15, 2020, under item 10.6 "Radiation Safety Program - Operating, Emergency, and Security Procedures," the licensee is required to implement and maintain the operating, emergency, and security procedures in Appendix G to NUREG-1556, Volume 1, Revision 2 and that copies of these procedures will be provided to all gauge users and will be available at each jobsite.

Contrary to the above, from January 5, 2017, through November 17, 2021, the licensee failed to implement, maintain, or provide copies of the above procedures across its operations. Specifically, the licensee did not have any documents or policies or procedures that would have approximated the committed model procedure, nor did the licensee provide any document, policy, or procedure to gauge users at each job site.

This was determined to be a SLIV violation (NRC Enforcement Policy 6.3.d). The licensee was provided a copy of and the online location for the NUREG-1556 document, printed out the Appendix G model procedure, and committed to training any gauge user and providing gauge user(s) these procedures for future gauge use.


