It is our sincere pleasure to invite you to the U.S. Nuclear Regulatory Commission's (NRC's) 34th Regulatory Information Conference (RIC). This year's RIC is scheduled for March 8–10, 2022. It will be a hybrid event, with in-person attendees participating at the Bethesda North Marriott Hotel and Conference Center and virtual attendees participating remotely by accessing the RIC conference platform.

The RIC, sponsored by the NRC Office of Nuclear Reactor Regulation and the Office of Nuclear Regulatory Research, offers an open environment in which diverse groups of stakeholders may learn, share, and discuss information on significant and timely nuclear regulatory activities and emergent issues.
