## SUBJECT: RESPONSE TO ORDER FOR IMPLEMENTATION OF ADDITIONAL SECURITY MEASURES AND FINGERPRINTING FOR UNESCORTED ACCESS FOR WOLF CREEK GENERATING STATION INDEPENDENT SPENT FUEL STORAGE INSTALLATION

Dear Mr. Reasoner:

The U.S. Nuclear Regulatory Commission (NRC) issued an Order (EA-20-091) on July 22, 2020, (Agencywide Documents Access and Management System [ADAMS] Accession No. ML20170B049), that modified the current license for Wolf Creek Nuclear Operating Corporation (WCNOC) Wolf Creek Generating Station, (WCGS) Independent Spent Fuel Storage Installation (ISFSI). The Order required compliance with additional security measures (ASMs) for physical protection and access authorization, and fingerprinting at ISFSIs. The WCNOC submitted its response to the Order for the WCGS ISFSI on August 11, 2020 (ADAMS Accession No. ML20224A530).

WCNOC notified the NRC in its August 11, 2020, reply that scheduled compliance with the ASMs would occur by July 22, 2021. WCNOC submitted revision 15 of the WCGS physical security plan (PSP) to the NRC, on May 27, 2021 (ADAMS Accession No. ML21167A180). The NRC completed an on-site physical security inspection at WCGS on October 6, 2021, documented in a report dated October 21, 2021 (ADAMS Accession No. ML21287A255). The inspection was performed to ensure compliance with the ASMs.

Based on our review, the NRC staff finds that WCNOC's PSP met the applicable performance objectives and general requirements outlined in Title 10 *Code of Federal Regulations*, Section 73.55, and the ASM imposed by the NRC Order EA-20-091 to be acceptable. The NRC has determined that WCNOC has effectively implemented the ASMs through the PSP
