Dear Mr. Hylas:

This is in reference to your letter dated July 20, 2021, requesting to transfer control of NRC License No. 12-28232-01. In order to continue our review, we need the following additional information. The section numbers below refer to NUREG-1556, Volume 15, Revision 1, "Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses" found at <https://www.nrc.gov/docs/ML1618/ML16181A003.pdf>.

1. Section 5.1, Description of Transaction – Please provide a copy of the document(s) authorizing or describing the sale of the licensee, H.W. Lochner, Inc., to Elysium Infrastructure Group, LLC. Please redact any information deemed sensitive prior to transmitting the document(s)
2. Section 5.1, Description of Transaction – Please provide both a pre- and post-transaction organizational chart showing the corporate structure of the license holder and its parent companies, if any.
3. Section 5.2, Changes of Personnel – Please describe any changes in members on Board of Directors or other personnel who have control over licensed activities. These may include, in some cases, officers of a corporation or other management individuals who are listed on the license or are referred to in the supporting documentation.
4. Section 5.6, Transferee's Commitment to Abide by the Transferor's Commitments - Please confirm that Mr. Christopher Hylas is authorized to make legally binding commitments on behalf of the acquiring company, including the commitment to abide by all constraints, conditions, requirements, representations, and commitments the transferor made previously to NRC.
5. Please provide additional information concerning the operations of the transferee. Please confirm whether Elysium Infrastructure Group, LLC or any of its subsidiaries currently possess any U.S. Nuclear Regulatory Commission or Agreement State issued licenses.

We will continue our review upon receipt of this information. Please reply to my attention at Jonathan.Pfingsten@nrc.gov.

In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this letter.

While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary.
