Enclosed is an application (XCOM1187/03), dated December 20, 2021, received by the U.S. Nuclear Regulatory Commission (NRC), from Sulzer Pumps (US) Inc. Export license XCOM1187/02 authorizes the export of replacement and spare parts for Primary Heat Transport Pumps, Shutdown Cooling Pumps, D20 Feed Pumps, D20 Recovery Pumps, Emergency Core Cooling Pumps, Emergency Water Supply Pumps, Liquid Zone Control Pumps, and Main Moderator Pumps.

The purpose of the amendment application is to: 1) update the applicant's address; 2) extend the license expiration date; 3) remove two U.S. Parties; 4) update address of an U.S. Party; 5) revise name of an U.S. Party; 6) add seven U.S. Parties; 7) add an Intermediate Consignee; 8) remove Emergency Water Supply Pump from the license equipment description; and 9) and lastly, update the estimated total value of equipment.

Before acting on this request, we would appreciate your views, in accordance with established procedures and from the overall perspective of the Executive Branch, as to whether the requested export meets the applicable criteria in the Atomic Energy Act of 1954, as amended.

Please note that the dollar amount on page one of the NRC Form 7 is proprietary information. The NRC will not include this information in the public record and requests that the Executive Branch agencies protect it as well.
