U.S. Nuclear Regulatory Commission Public Meeting Summary

Purpose of the Meeting(s):

To provide updates on ADAMS and answer questions from public ADAMS users.

General Details:

The meeting began at 2:10 p.m. with introductions and general announcements by Anna McGowan, Branch Chief, and Bebbie Rhodes, Library Team Leader. Four NRC librarians attended.

Approximately 17 ADAMS User Group members attended, five of whom were NRC staff (Office of the Chief Financial Officer, Office of the Chief Information Officer). The members of the public represented Oak Ridge Associated Universities (contractors for the National Institute of Occupational Safety and Health); Winston & Strawn, LLP; Idaho National Laboratory; S&P Global Platts; Los Alamos National Laboratory; University of Wyoming; MPR Associates; and Boston Children's Hospital. All participants joined remotely, using a teleconference line.

The remaining portion of the meeting covered ADAMS User Group member issues and questions. The meeting ended at 2:45 p.m.

Visiting the Public Document Room

Digitization of ADAMS Public Legacy Library Documents

Over 2 million documents have been digitized from the ADAMS Legacy Library. In cooperation with staff from the Office of Public Affairs, we have developed an instructional video to help users locate Legacy Library documents by using ADAMS Legacy Library accession numbers. We plan to create similar instructional videos in 2022 to support and promote user access to Web-based ADAMS. The "ADAMS How-To" video series is available from the NRC YouTube channel and is also linked from the NRC Web page at <https://www.nrc.gov/reading-rm/adams.html>.

Member Issues and Questions:

Member Question: Will the NRC honor its commitment to the public to increase the number of displayed search results in public ADAMS in the coming year? Presently, there is a limit of 1,000 displayed results, which is inadequate for some searches.

NRC Response: The technical staff has been working on increasing the number of records displayed, but system performance issues have slowed progress. As a solution, we revised the indexing procedures and optimized the queries to improve performance and retrieval. At the start of 2022, we plan to increase the virtual resources on the server and remove the limit on search results. We will also monitor the server so that we can assess performance if slowness is detected after the limit is removed.

Member Question: Can you explain the nuances of how microfiche have been digitized and how to search for these documents? Were there any technical issues in getting the microfiche digitized? How many documents are still to be digitized?

NRC Response: To locate digitized documents, use an accession number from the ADAMS Legacy Library and go to the ADAMS Main Public Library. Select "Document/Report" in the Document Properties section, leave the operator field as "starts with," and enter "NUDOCS [space]" and the Legacy Library accession number as the value.

The NRC has digitized 2 million documents and added them to the ADAMS Main Library. We are still working to review and release a further few hundred thousand documents. For some records, we do not have metadata, so we must determine a process to add them to the Main Library. We are also working on digitizing a thousand boxes of Atomic Energy Commission documents. We have digitized 200, but until the Federal Records Center provides greater access to the physical documents stored there, we cannot gain access to them because of COVID-19 precautions. Currently, the Federal Records Center is only open for limited hours and is minimally staffed.

The PDR still has the publicly available Docket 50 microfiche, which have not yet been digitized. These records can be searched through the ADAMS Legacy Library, and copies can be requested through the PDR.

Member Comment: I am hoping Docket 50 will get digitized. That would help. Docket 50 is gold for plant histories.

NRC Response: We will follow up on this after the Office of the Chief Information Officer staff examines the Docket 50 microfiche in the PDR.

Member Question: Is the document copy contract still a viable option during the COVID-19 pandemic? Do we still have to establish an account with the contractor? Does the contractor do rush orders and/or do they typically turn around the order in 1 day?

NRC Response: We have been able to meet with the contractor during COVID-19. We give them the order, and they supply the documents to the requesters. We now meet with the copy contractor on a weekly basis as needed, rather than on a daily basis. Requesters do not need a prior account with the contractor, but they do need to provide credit card information when placing the order. There is no longer a provision for "rush" service, but the contractor usually complete orders on the same day it picks up the microfiche.

Action Items/Next Steps

Bebbie Rhodes thanked participants for attending. The next ADAMS User Group meeting will take place in autumn 2022.
