Dear Ms. Gerfen:

On October 28, 2021, the U.S. Nuclear Regulatory Commission (NRC) completed an onsite inspection at the Diablo Canyon Power Plant. Additional offsite inspection related activities continued through December 30, 2021, when the results of this inspection were discussed with Mr. Adam Peck, Senior Director, and other members of your staff. The results of this inspection are documented in the enclosed report.

Two findings of very low security significance (Green) are documented in this report. Two of these findings involved violations of NRC requirements. We are treating these violations as non-cited violations (NCVs) consistent with Section 2.3.2 of the Enforcement Policy.

If you contest the violations or the significance or severity of the violations documented in this inspection report, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001; with copies to the Regional Administrator, Region IV; the Director, Office of Enforcement; the Director, Office of Nuclear Security and Incident Response; and the NRC Resident Inspector at Diablo Canyon Power Plant.

The following cross cutting aspect was assigned to findings using Inspection Manual Chapter 0310 "Aspects Within Cross Cutting Areas:" two [H.3] - Change Management.

If you disagree with a cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk,


