Dear Mr. Rhoades:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2020-011) on June 18, 2020, to determine whether a maintenance supervisor in the Limerick Generating Station's (Limerick's) Fix-it-Now (FIN) Team deliberately falsified records to cover up work hour rules violations. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the supervisor deliberately falsified records to cover up work hour rules violations.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
