1) Programmatic Agreement status – NRC accepting comments until January 20; Lee Anna asked who the NRC is working with in the NN THPO's office and Ashley replied that Richard Begay and Tamara Billie are the contacts. Lee Anna may submit a comment on the PA re: notifications to NN THPO, not just the NM SHPO.

Lee Anna asked about the comment period end date and NRC staff clarified that it is January 20.

Action: NRC staff will send an email to the distribution clarifying that the comment period end date is January 20. Email sent 1/14.

2) EIS status/NNEPA review – NRC provided an update on status of final EIS development; noted that we intend to give the preliminary draft Final EIS to other government agencies (federal, state, and NN) at the end of February (2/28). Agencies will have two weeks to review for major issues. NRC is available for phone calls to assist NNEPA staff in reviewing the document.

NNEPA staff asked if we will share the draft EIS with groups other than the NNEPA (e.g., RWPR community, DURAC). The NRC responded that we intend to share the document with government agencies only, not the general public. NRC staff clarified that our process does not include providing a second public comment period for review of the NRC's proposed responses to public comments on the draft EIS. Our sharing a preliminary draft of the Final EIS with other government agencies is being done as a courtesy.

Action: During the February 11 NNEPA/NRC call, we will discuss specific dates/times for early March NRC/NNEPA call(s) to walk through the draft Final EIS.

3) Other items of interest?

Lee Anna asked whether we published newspaper articles in December regarding the PA? Ashley responded that we published ads in December and January in the Gallup Independent and Navajo Times.

Next NNEPA/NRC call is Friday, February 11.
