**SUBJECT: DRAFT TECHNICAL MEMORANDUM, REQUEST FOR UNRESTRICTED RADIOLOGICAL RELEASE OF SELECT OPEN SPACES, INSTALLATION RESTORATION SITE 12, FORMER NAVAL STATION TREASURE ISLAND, SAN FRANCISCO, CALIFORNIA**

In September 2018, the Department of the Navy (Navy) submitted the subject document for review by the California Department of Toxic Substances Control (DTSC) and the California Department of Public Health – Environmental Management Branch (CDPH).

The draft memorandum provided information supporting a request for a radiological unrestricted release recommendation (RURR). The RURR covered the area of Site 12 outside of the solid waste disposal areas described as “open spaces” in the subject document.

Comments on the draft memorandum were provided to the Navy by DTSC and CDPH in May 2019 and June 2019, respectively. After much discussion and consideration, it was decided that only Appendices A and B from the subject document would be finalized.

In November 2020, those appendices were finalized as the following documents: *Revision 1 Technical Memorandum Installation Restoration Site 12 Scoping Survey Follow up Investigation, Former Naval Station Treasure Island, San Francisco, California* and *Revision 1 Technical Memorandum Installation Restoration Site 12 Scoping Survey Open Spaces and Residential Housing Units, Former Naval Station Treasure Island, San Francisco, California* (Aptim, November 2020).

This letter documents the Navy’s formal retraction of the request for the CDPH RURR per the subject memorandum. The Navy will continue to collaborate with DTSC and CDPH to reach consensus on the conceptual site model for discrete radiological objects and may resubmit a future request for a CDPH RURR determination for Site 12.
