Dear Dr. Salmon:

Enclosed is Amendment No. 73 to your NRC Materials License No. 13-02128-03 in accordance with your request dated November 15, 2021.

Thank you for the update regarding the relocation of the HDR unit for storage and use as approved in the previous Amendment No. 72. Also, please note that we have added and deleted several authorized users as you requested, with one exception. As discussed with you by telephone on January 26, 2022, we were unable to grant the additional authorization for 10 CFR 35.396 use as requested for Sandeep Bhawe, M.D. Specifically, the required information in 10 CFR 35.396(b)(1) and (b)(2)(i – v) was not addressed in the training and experience provided for Dr. Bhawe. You indicated that we should proceed with the remainder of the amendment request as you determine how to address the deficiency noted above.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
