Chris, below is the answer from my POC at RASO. If you feel that it needs to be added back to the list just let me know. Lino

Just spoke with San Diego – here is the current status of Imperial Beach Site 6. The identified Radium commodities were disposed of via Rock Island about 2 years ago, and since then the only remedial work being conducted on site has been for PFAS – drilling wells, etc. There is still roughly 8,000 cubic yards of burn debris on site that needs to be assessed, and they suspect that there will be additional rad commodities found. That work isn't going to happen until at least FY24 or FY25.

So, as the site was on the list previously, perhaps it should remain, but it is still only suspected that

rad commodities still exist there, albeit the odds are likely, based on historical experience.

- NWS Concord Bldgs IA-20, 21, 21A, IA22 & Special Weapons Magazine 2ATX72 (BRAC site with no contamination identified as yet)
- NOLF Imperial Beach Site 6 (ER,N site with potential LLROs in area where PFAS sampling being conducted)
- NAS Jax Bldg 101 renovation (MILCON site with suspected contamination in pipe from former paint shop)

I have looked over the inventory you provided earlier and have a few questions:

- Of the four DON sites that were removed from the inventory beginning this year (i.e., MCAS Cherry Point, NWS Concord, NAS Jacksonville, and NOLF Imperial Beach), I understood from discussions with the specific sites last year that Concord did not have confirmed contamination. However, its not clear why Cherry Point, Jacksonville, and Imperial Beach are removed from the inventory beginning this year. Could you help me understand why these sites were removed beginning this year?
- In the spreadsheet you transmitted, the DOD Inventory tab didn't include the Army sites. I presume Sharpe Army Depot and Dugway Proving Ground, which were listed under the Army tab are still part of the inventory. Please clarify whether my assumption regarding their status on the inventory is correct.

I am happy to set up a call to discuss further if needed. Feel free to let me know your preference.
