**SUBJECT: COAL-MAC LLC (FORMERLY SOUTHEASTERN LAND, LLC), LICENSE
AMENDMENT, MAIL CONTROL NO. 625769**

Dear Mr. Adams and Mr. Potter:

This refers to the license amendment request dated March 8, 2021. Please find enclosed Amendment No. 4, transferring the license from Southeastern Land, LLC to Coal-Mac LLC; and authorizing Doug Boyd as the new Radiation Safety Officer.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

There are letters of commitment in the last condition of the license, that remain from the former licensee's program because they are related to the use of portable gauges, which are not covered by the Coal-Mac LLC radiation safety program. Of particular note is the required training for portable gauge users, which is different than that for fixed gauges, and the additional requirements for security and accountability of portable gauges at temporary job sites. Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
