This refers to your license amendment request dated October 11, 2021. Please find enclosed Amendment No. 36 removing the location of use at 290 Churchman's Road, New Castle, Delaware. This facility may now be released to the public.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
