This correspondence refers to your license amendment requests dated December 19, 2021 and January 28, 2022. Please find enclosed Amendment No. 81 in accordance with your requests.

An environmental assessment for this action was not required, since this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) 51.22(c).

In your request dated December 19, 2021, you provided close-out survey results for a location of use at 605-625 W Second St., Bloomington, Indiana 47403. You also confirmed that all residual licensed material used at this location had been removed – such that any remaining residual radioactivity is within the limits of 10 CFR Part 20, Subpart E.

Based on its review of close-out survey information, the staff has concluded that all licensable radioactive material has been removed from the location of use and residual radioactive material attributable to licensed activities in this location of use does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required. Your facility at 605-625 W Second St., Bloomington, Indiana 47403 is suitable for unrestricted use.

You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking your license as specified in the NRC Enforcement Policy.
