Enclosed is Amendment No. 73 to your NRC Material License No. 21-11850-01.

This Amendment replaces the version issued on May 21, 2020, which was inadvertently issued as a duplicate version of Amendment No. 72.

The version of Amendment No. 72, dated July 6, 2020, and signed by Cassandra F. Frazier, did not include the changes requested in your letter dated January 2, 2020.

The removal of authorized users Drs. Rahi, Habbal, Munaco, T. Parikh, Denier and Rashid were not on the July 6, 2020, version of Amendment No. 72. Drs. Dalal and Hong did not appear as AU's on the July 6, 2020, version of Amendment No. 72.

These changes were made on the duplicate Amendment No. 72, which was signed and dated and valid as of May 21, 2020. The authorizations on both versions of Amendment No. 72 are valid and there should be no effects on your license as a result of these errors.

We discovered that there was a synchronization issue in our Web Based Licensing System (WBL) that contributed to this situation that has been rectified at this time.

We are only correcting the Amendment Number sequence for your license and bringing the WBL version of your license current.

We apologize for these errors and for any inconvenience they may have caused you.
