This letter documents the U.S. Nuclear Regulatory Commission (NRC) staff’s plan to perform an inspection of Global Nuclear Fuel – Americas, LLC’s (GNF-A) Appendix B, “Quality Assurance Program Criteria for nuclear Power Plants and Fuel Reprocessing Plants,” to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, “Domestic Licensing of Production and Utilization Facilities,” 10 CFR Part 21, “Reporting of Defects and Noncompliance,” and 10 CFR 73.21, “Protection of Safeguards Information: Performance Requirements,” programs as they pertain to activities conducted at your facility related to the design and manufacturing of nuclear fuel and core support components for NRC’s regulated facilities. As discussed via electronic mail on February 2, 2022, the NRC inspection team plans to arrive at your facility on Monday, March 21, 2022 and will conduct the inspection through Friday, March 25, 2022.
