By letter dated October 4, 2021, Tennessee Valley Authority (TVA) submitted Amendment 29 to the Browns Ferry Nuclear Plant, Units 1, 2, and 3, Updated Final Safety Analysis Report (UFSAR), as required by Title 10 of the *Code of Federal Regulations*, Section 50.71. The U.S. Nuclear Regulatory Commission (NRC) staff has performed a review of the UFSAR to identify and remove sensitive, unclassified non-safeguards information (SUNSI) in accordance with agency policy for protecting SUNSI. The NRC staff reviewed information redacted by TVA and has determined that the redactions do meet the criteria for SUNSI and will be withheld. However, during its review, the staff identified additional information that meets the SUNSI criteria and have redacted the following additional information:

Chapter 2: redactions in Section 2.4, 2.4A, and Figure 2.2-4 Chapter 8: redaction of title of Figure 8.6-1c Chapter 10: redaction in Section 10.12 Appendix N: redaction of the header in Unit 1's report
