Dear Ms. Aubain:

This refers to your license amendment request dated October 19, 2021. Please find enclosed Amendment No. 31 authorizing the change of your license from a Type A License of Broad Scope for Research and Development to a limited scope license for use of sealed sources and devices as analytical instruments. Please note that the license authorizes small quantities of unsealed materials as residual contamination, until the results of the final surveys of the remaining facilities previously used for research and development are submitted for review and approval of the release of those facilities.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
