Subject: La Crosse Boiling Water Reactor (LACBWR) Annual Radiological Environmental Operating Report

In accordance with the Quality Assurance Program Description (QAPD), Appendix C, Section 2.5.1, "Annual Radiological Environmental Monitoring Report," and Section 2.5.2, "Annual Radioactive Effluent Release Report," the 2021 reports for Facility Operating License No. DPR-45 and the Independent Spent Fuel Storage Installation are required to be submitted prior to March 1. This letter is being sent to communicate the shipment of environmental TLDs for the site were delayed due to supplier issues; therefore, the dose reports for the LACBWR have not yet been received. The 2021 Annual Radiological Environmental Operating Report, which includes the Radiological Environmental Monitoring Report and the Radioactive Effluent Release Report, will be provided as a supplement to this letter once the dose reports are received and the reports have been developed.

The Radioactive Effluent Release Report outlines changes to the Process Control Program (PCP) per the requirements of the QAPD, Appendix C, Section 2.1, "Process Control Program." The PCP was not revised in 2021.

The Radioactive Effluent Release Report also outlines changes to the Offsite Dose Calculation Manual (ODCM) per the requirements of the QAPD, Appendix C, Section 2.2, "Offsite Dose Calculation Manual." The ODCM was not revised in 2021.

There are no new regulatory commitments in this submittal.
