Mr. Gallaghar:

As discussed by phone on February 16, 2022, West Virginia United Health System, Inc. d/b/a West Virginia University Health System ("WVUHS" or the "System") is in the process of an internal governance restructuring (hereafter the "Restructuring"). As a result of the Restructuring, WVUHS will become the direct parent for the hospitals listed below, which have materials licenses issued by the Nuclear Regulatory Commission ("NRC") (hereafter "NRC Materials Licenses"). WVUHS is submitting this notice letter to confirm whether any further action will be needed by the NRC as a result of the Restructuring.
