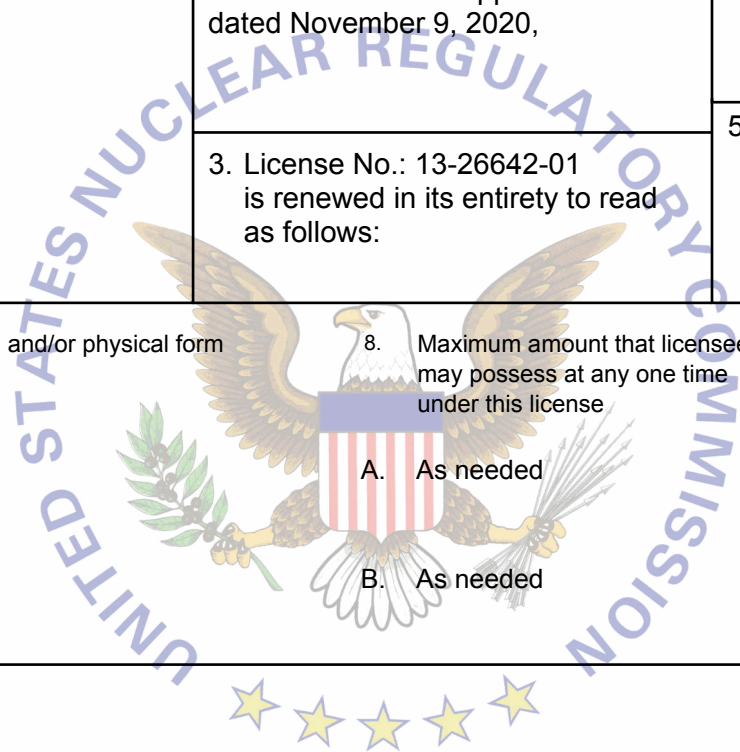


MATERIALS LICENSE
