Subject: Concerning the Letter from Dr. Stanton RE: CAs at CAMC

Discussion: As part of a teleconference regarding the corrective actions and ongoing review of licensed activities at Charleston Area Medical Center (CAMC), Mr. vonEhr requested clarification regarding an unprompted letter received by Mr. vonEhr from Dr. Stanton, an AU at CAMC and RSO/AU at H. James Stanton Cardiology. The letter concerned corrective actions (CAs) agreed to by the cardiologists and the Cardiovascular Medicine Department at CAMC, and by extension third-party medical practices run by cardiologists outside of CAMC. The clarification was because this letter was not provided through established channels of communication for the CAMC inspection (hospital leadership or Ms. Layton and Dr. Lowe). Ms. Layton and Dr. Lowe confirmed the actions described within the letter to be an accurate representation of actions taken at CAMC to address the challenge of multi-facility occupational monitoring.

ACTION: upload a copy of Dr. Stanton's letter, along with this telephone record, into both licensee's (CAMC and H. James Stanton Cardiology) dockets.
